

The term '**iMathTutor**' or 'us' or 'we' refers to the owner of the website, Regis J. Serinko, Jr., whose mailing address is Calder Square, P.O. Box 10456, State College, PA.

This Membership Agreement (the "Agreement") is a legal contract between the customer ("You", "Your", User, etc) and **iMathTutor**. The Agreement governs your purchase of subscriptions to various online resources (Practice Tests, Solution Sets, Quick Reference Guides, Video Lectures, etc...), whether fee-based or free of charge, offered on **iMathTutor's** website (each a "Subscription"). Your use of the Subscriptions is conditioned on your acceptance of this Agreement. **iMathTutor** grants you a personal, limited, non-exclusive, revocable license to access and use your Subscriptions for your personal use subject to Agreement. **iMathTutor** reserves the right to change or discontinue any aspect or feature of the this website, including, but not limited to, content, hours of availability, and equipment needed for access or use, at any time without notice or liability to you.

You might not always be able access your subscriptions due to technological problems or site maintenance.

## 2. REGISTRATION PROCESS

To sign up for or receive any Subscription, you must establish an account by submitting or maintaining on file with **iMathTutor** certain registration data, as requested by **iMathTutor's** online registration form for the Subscription. Such registration data shall include, but not be limited to, your name and email address.

(a) All of the registration information you supply to **iMathTutor** is true, complete, and accurate, and you will notify **iMathTutor** of any changes to your registration data during the term of this Agreement and submit updated information within twenty (20) days of any such changes;

(b) You will have only one active account and you will safeguard your account user name and password by not disclosing your password to any third party, and you will assume responsibility for any and all harm or

liability attributable to you or any other person accessing your account or any Subscriptions with your user name and password;;

(d) You will not log in to your account concurrently from multiple IP addresses or log in to your account from more than five (5) IP addresses in any consecutive twenty-four (24) hour period;

Completion and submission of any Subscription activation form authorizes **iMathTutor** to charge the credit card specified in your registration for all such fees and any related taxes corresponding to the selected Subscription.

##### **Section 4.2. Method of Payment.**

**iMathTutor** accepts payment by PayPal. **iMathTutor** does not have access to nor does it store any credit card data on our servers. All credit and payment data is stored securely by our credit card merchant (Paypal).

#### **5. MODIFICATIONS**

**iMathTutor** has the right to change or modify the Membership Agreement, applicable to your use of the **iMathTutor** website, or any part thereof, or to impose new conditions. Such changes, modifications, additions or deletions shall be effective immediately upon notice thereof, which may be given by means including, but not limited to, posting within the **iMathTutor** website, or by electronic or conventional mail, messaging, or by any other means by which you may obtain notice thereof. Any use of the **iMathTutor** website by you subsequent to such notice shall be deemed to constitute your acceptance of such changes, modifications or additions.

#### **6. DURATION OF SUBSCRIPTIONS**

Each Subscription begins at the time of completion of the registration and receipt of payment and will continue to a fixed date as specified on the **iMathTutor**'s web pages applicable to the the given Subscription.

#### **7. TERM AND TERMINATION OF AGREEMENT**

The term of this Agreement will begin on the date that **iMathTutor** accepts your registration and will continue in force until the expiration of all of all subscription plans for which you have registered. **iMathTutor** also reserves the right to terminate your account and this Agreement immediately and without notice in the event that you breach any provision of this Agreement. No refunds will be available on account of any termination of this Agreement. Sections 10 through 13 of this Agreement shall survive and remain in effect

notwithstanding any termination of this Agreement.
